

### Competition Rules:

**Equipment:** Required for sparring are a chest protector, head gear, mouthpiece, groin guard, forearm and shin protectors.

**Sparring Rules:** Modified current rules and regulations of the WTF will govern this event. Please note that there will be no head contact allowed in this event.

**Poomse Rules:** The only poomse accepted are the Taegeuk and Palgwe series for colored belts, and Koryo for 1<sup>st</sup> Poom, Keumgang for 2<sup>nd</sup> Poom, Taebaek for 3<sup>rd</sup> Poom.

**Breaking Rules:** Ages 6 and under, maximum 2 stations. Ages 7 and over, maximum 3 stations. Boards are included.

Take exit 42 for Dascomb Road, Tewksbury.

Turn left at Dascomb Road.

Continue straight to stay on Dascomb Road (0.4 mi).

Continue onto East Street (2.6 mi).

Slight right turn on to MA-38 North/ Main Street.

Behind Deli King Restaurant on the left.
